Agenda and Discussion

CALL TO ORDER

Mr. MacLeod opened the meeting at 5:45 pm

Reading of Land Acknowledgement.

Distributed agenda was adopted by Ms. Adams, seconded by Mr. Corbett.

DISCLOSURE OF INTEREST

None.

ADOPTION OF THE MINUTES

Minutes of the Combined Striking Committees meeting held on April 11, 2024 were adopted by Mr. Blanchard and seconded by Ms. Adams.

REGULAR BUSINESS ITEMS

- Beach Bash Volleyball Tournament banner
 - Administration noted that the Beach Bash Volleyball tournament which was held on May 25, was a success.
 - Administration noted that Pro Men and Women played over the weekend.

- Administration noted that the next tournament will be held the weekend of August 23, 2024.
- Administration noted that complaints were filed about the sand flying onto Ouellette Avenue and onto neighbouring businesses.
- Motion made by Mr. Corbett to "approve a budget of up to \$500 for a banner for Ouellette side of the Khan courts."
- The Motion was seconded by Ms. Holt, and approved.

Dog Days of Summer

- Administration noted that the Dog Days of Summer will be held on Saturday, July 27, in the Pelissier Street Parking Garage.
- There will be approximately 40 vendors, as well as a dog trainer, a dog fashion show.

Canada Day Arts Fair

- Administration noted that the Canada Day Arts Fair will take place on Monday,
 July 1, between 10am-2pm, on University Ave., between Ouellette and Pelissier.
- The Canada Day Parade will take place between 11am-1pm and will travel down Ouellette, past University, to Riverside Drive and west to Caron Ave.
- Administration noted that the biggest issue is that many downtown businesses are closed on Canada Day.
- O Discussion surrounded incentivizing businesses to open on Canada Day for all of the Parade and Arts Fair visitors.
- Discussion continued regarding notifying all businesses about the Canada Day Parade and the number of visitors that this brings to the downtown core, and providing businesses with posters and postcards.

NEW BUSINESS ITEMS

Desiree Jackson - LidLock

- Desiree presented and demonstrated the LidLock she'd invented and discussed her sales goals.
- Discussion surrounded the costs for bulk buys, and whether this should be marketed to bars and restaurants.
- O Discussion also surrounded other user groups, such as the Health Unit's Substance Prevention Team, and possible interest in the product from these groups.

• St. Leonard's House - cleaning costs

- Administration spoke to the cost of paying for cleaning of the downtown including the Downtown Mission area.
- O An issue of concern is that the area is cleaned and then people get into the garbage bins and garbage is strewn about again.
- The Board spoke of approaching the Executive Director of the Mission and suggesting that the DWBIA would pay to extend their fence so that the garbage bins are in their area and it becomes their responsibility to clean.
- Motion made by Mr. Agostino to "spend up to 3000 for a fence for garbage at Downtown Mission."
- o The Motion was seconded by Mr. MacLeod, and approved.

Planter Proposal

- The DWBIA was approached by the owners of The Squirrel Cage to build planters along the alleyway behind their property to help with beautification and were asking for funding from the DWBIA for this project.
- Discussion surrounded ways to keep the cost down and to do this ourselves. Board members to reach out to different contacts they have regarding the cost to construct this as well as the cost of plants, perhaps at cost.

TWEPI - AGM

- Administration noted that the TWEPI AGM will be held on Thursday, June 13 at Caesars Windsor. Administration asked if any Board members were interested in attending.
- Tickets will be purchased next week for attendees.

Gord Smith Healthy Workplace Awards Ceremony

- Administration noted that the GSHWAC will take place on Wednesday, June 5, from 8-11am at the St. Clair Centre for the Arts.
- Administration noted the Mr. Agostino will be the speaking dignitary, and asked if any Board Members were interested in attending.

Downtown Block Parties

 Based on the success of the NFL Draft Block party, the Board discussed adding additional events this summer. The dates decided upon were

Saturday, June 29 Saturday, July 27 Friday, August 9 Saturday, September 14

- Motion made by Mr. MacLeod to "organize four downtown block parties on June 29, July 27, August 9 and September 14. Budget of \$50,000 to be taken from Farmers' Market revenue."
- o The Motion was seconded by Ms. Holt, and approved.

• Maiden Lane – 5th Anniversary

 Administration noted that Maiden Lane Wine & Spirits would like to use our hydro box for the duration of their annual event. There is a cost of staffing in the amount of \$180 (36 x 5 hrs). The Striking Committee approved this spend.

US Marketing Campaign

 Decision made to table this item for discussion at the Board of Directors meeting held on Tuesday, June 4.

Parking meters

- Mr. Agostino noted that City Council will be meeting on June 10 and the final decision will be made regarding modernizing parking operations throughout the city.
- If the decision goes as expected, paying at individual parking meters will be phased out. There will be signage, and payment will be at one location for a certain area.
 Parking tokens that are out in the community will be able to be used for a certain time frame while this change takes place.
- Discussion surrounded how this will impact the Farmers' Market and other events where there is no on street parking and meters are bagged.

Security Cameras - update

- o It was noted that a meeting was held between Administration, some members of the Executive, and the Town of Chatham regarding their municipality's camera program.
- o It was noted that an upcoming meeting with the Police Chief is planned, and this will be a matter up for discussion.

June 19 – clean up

New Business Downtown

- Discussion surrounded new businesses planning on coming to the Downtown.
- Discussion surrounded whether the Business Incentive Programs should be revisited.

- Discussion surrounded starting a database of empty storefronts and approaching the owners one by one to find out what their plans are for the space.

CALL TO ORDER

Mr. MacLeod opened the meeting at 5:49 pm.

REGULAR BUSINESS

Douglas Sartori, Parallel 42 – Digital Asset Management Solution

- o Mr. Sartori presented and discussed the 2 options in the Digital Asset Management Proposal, as prepared for the Downtown Windsor BIA.
- Discussions surrounded the DWBIA's needs, upfront and ongoing costs upfront, and Mr.
 Satori's recommended solution.
- Motion made by Mr. Agostino for "On Premises storage solution for digital management."
- o The motion was seconded by Mr. Bhatti, and approved.

Walkable Windsor – Windsor Society of Architects

- Administration spoke to the events taking place on Tuesday, June 11 and Wednesday, June 12, 2024.
- The events on June 11 include an invitation-only walking tour of downtown, followed by a
 Welcome Reception at 5:30 pm as well as a lecture by Guest speaker, Jeff Speck, at
 6:00 pm at the St. Clair Centre for the Arts. The evening events are open to the public.
- The breakfast event on June 12 is by invite only and the invitee must have attended the lecture on June 11.

Volleyball Court Rentals – Application from Shawn Lippert

- Administration noted that the booking rentals for the courts went live today.
- Applications received will be discussed and decided on, on a case-by-case basis, by the DWBIA Striking Committee and/or Board of Directors.
- o It was suggested that Notices of Upcoming Events be distributed to residents in the apartment buildings beside and across the street from the courts, prior to any private events taking place in Khan Courts.
- Mr. Lippert's application is for a Dance Party in the Sand, to take place on August 3,
 2024 between 2-10pm. This will be a ticketed event.
- Motion made by Mr. Corbett for "approval for volleyball court rental from Shawn Lippert."
- o The motion was seconded by Ms. Adams, and approved.

• Notice of City Council meeting – Item 11.2 – City Hall Square Ice Rink

- City Council convenes on Monday, June 10 at 10 am to discuss the proposed City Hall
 Square Ice Rink to be located at the Civic Esplanade.
- Discussion surrounded whether a letter of support would suffice or whether a delegate should attend to speak in support of this agenda item.
- Mr. Blanchard will be registered as a delegate and will speak in support of the issue on behalf of the DWBIA.

Notice of City Council meeting – Item 8.10 Options for Modernization of Parking Operations – City Wide

- At its meeting on June 11, City Council will also discuss the report on the modernization of parking operations throughout the municipality.
- o Mr. Blanchard will again be registered as a delegate to speak in support of the agenda item, and the benefits to the downtown core.

• St. Leonard's House – cleaning cost - fencing

- Discussion surrounded the continued cost to cleaning the area around the Downtown Mission.
- Discussion included the DWBIA getting a better sense of the hours in which garbage was most prevalent in order to be able to make an informed decision of how best to tackle this ongoing issue.
- Motion made by Mr. Corbett to "approve a budget of \$2500 to research and generate a report of peak times for high traffic and high volume of garbage at the downtown mission."
- o The Motion was seconded by Mr. Agostino, and approved.
- The Board of Directors noted that conversations have taken place between the Downtown Mission, Administration, and Board representatives regarding the idea of adding additional fencing around the garbage bins to keep the litter contained to their area, and to be good community neighbours.
- Next steps are to get a quote for fencing, as well as a separate quote for wraps for the fencing.

Block Parties 2024 – discussion and approval

 The Motion made at the May 30, 2024, Striking Committees meeting, was read to the Board of Directors and approved.

US Marketing Campaign

- Mr. Corbett proposed setting aside funds for a US Marketing campaign, targeting the 19–25-year-old demographic, for a period of 3-4 months, to bring additional customers back to the downtown core.
- Discussion surrounded an outstanding marketing grant application, and funds that have been earmarked for Marketing.
- Motion made by Mr. Corbett to "approve a budget of up the \$20,000 for a USA marketing campaign to attract more customers to the downtown core, coming from the Farmers' Market budget. Direction to work with community partners to raise more funds."
- o The Motion was seconded by Mr. Bhatti, and approved.

Downtown Windsor Clean up – United Way and Rocket Mortgage

- Mr. MacLeod noted that the Downtown Windsor Clean Up takes place on Wednesday, June 19.
- He noted that approximately 100 people will be taking part in the clean up and that currently, no additional people are needed. If that changes, the organizers will advise Mr. MacLeod know.
- Mr. MacLeod requested 100 of the Our Downtown T-shirts be set aside and allocated to the event, to be worn by clean up participants.
